SUMMARY – An ordinance to amend the official zoning map to reflect certain zone changes.

ORDINANCE NO. 3797
(of Clark County, Nevada)

AN ORDINANCE TO AMEND THE OFFICIAL ZONING MAP RECLASSIFYING CERTAIN PROPERTIES AS APPROVED BY THE BOARD OF COUNTY COMMISSIONERS THROUGH VARIOUS ZONE CHANGE APPLICATIONS ON May 20, 2009.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CLARK, STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. In accordance with the provisions of Title 30 and the actions of the Board of County Commissioners on May 20, 2009, the following described properties are reclassified as follows:

ZC-1135-08

From R-1 (Single Family Residential) Zone, R-5 (Apartment Residential) Zone, and C-1 (Local Business Zone) to H-1 (Limited Resort and Apartment) Zone. That land situated in Clark County more particularly described as follows: A portion of the NW1/4, SE1/4, of Section 15, Township 21 South, Range 61 East described as Parcel 1 of Parcel Maps, filed in File 5, Page 88, recorded May 27, 1975, in Book 521, as Document No. 480243.

GENERALLY LOCATED: WEST SIDE OF CAMBRIDGE STREET, 300 FEET SOUTH OF KATIE AVENUE (ALIGNMENT).

APN: 162-15-701-010

SECTION 2. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, part of ordinances, chapters, sections, subsections, clauses, phrases, or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with name of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.




