Fall 2009 Registration Information

Mail-In Registration begins: August 14, 2009
Walk-In Registration begins: September 8, 2009
Program Dates: August 31 – December 18, 2009

RecTrek is extremely popular and available space in the program fills quickly. Priority for registration will be given on a first come, first serve basis. Mail in registration that is postmarked before the mail in date will be returned. Drop in registration is accepted if space is available. Online registration is not available although you CAN now register by credit card in person at the center.

What parents need to know?

- RecTrek is designed for children ages 6 – 12 (may be age 5 and have completed kindergarten)
- RecTrek hours: Monday – Friday from 7:00 a.m. – 6:00 p.m. Participants are required to bring a lunch and two snacks that do not need heating or refrigeration.
- All RecTrek participants will be required to pass a swim test prior to participating in any swimming activities or field trips. Swim dates and times will be announced in advance at each location. Parents may escort their child to any Clark County pool in order to obtain a swim test certificate

What does it cost to join RecTrek?

- \$15 per day or \$70 per week, per child
- There is a 50% discount for the third child if enrolling three children for the entire week (from the same family)
- Field trips will be offered at an additional fee.
- CCAP assistance may be available to those who qualify.
- A late pick-up charge of \$5 will be assessed for every 10 minutes the child/children are not picked up beginning at 6:00 p.m., and must be paid the same day.



What can my child do at RecTrek?

- Paint, draw, make crafts and do special theme projects.
- Play sports, games, take field trips, and have free time on the playground.
- Enjoy skits, drama, movies, and science projects.
- Have fun with friends.

How do I reserve a spot for my child?

- Payment in full is required to reserve a spot.

That's a lot of money up front. Do I have any payment options if my child will be attending for several weeks?

Yes, if your child will be attending more than two full weeks consecutively, you can reserve your spot by paying for the first two weeks. The remaining payments will be due by 6:00 p.m. each Wednesday for the upcoming week. Your spot will not be held if payment is not received by the deadline. Remember: this optional payment plan is for consecutive full weeks only. Breaks in attendance do not qualify for this payment plan.
